- No required early learning framework.

Capacity & Staff:Child Ratios

- Licensing dictates the capacity of children in a classroom space
- · Ratios:
  - Infant 1:3 (maximum 10 infants in a program)
  - Toddler 1:5 (maximum 15 toddlers in a program)
  - Preschool 1:8 (maximum 24 preschoolers in a program)
  - Kindergarten 1:13 (maximum of 26 kindergartens in a program)
  - School Age 1:15 (maximum 30 school-agers in a program).

\*Ratios of children are greater in the early morning hours and evening hours of operation.

- A maximum of six children, 13 years of age or under is the capacity for operating a licensed child care home
- Maximum capacity includes the provider's own children who are under the age of 4 years old
- Mixed age groupings are permitted, with no more than three children 2 years of age or under.
- A maximum of five children, 13 years of age or under is the capacity for operating a licensed child care home
- Maximum capacity includes the provider's own children who are under the age of 4 years old
- Mixed age groupings are permitted, with no more than three children 2 years of age or under.

Licensing,
Monitoring,
&
Inspection

• The Ministry of Education and Public Health licenses, monitors and inspects child care centres.

- The Ministry of Education does not license individual child care homes, instead, a child care home agency is licensed by the Ministry of Education
- The child care home agency licenses, monitors, and inspects child care homes
- A child care home agency's <u>home visitor</u> (a person who is hired to monitor and inspect) must have a minimum of a two-year diploma from an accredited College or University in Early Childhood Education/Studies and is registered with the College of Early Childhood Educators (CECE).

- Is not monitored or inspected unless a complaint is made
- Registry of Unlicensed Child Care Violations

Staff Qualifications

- Registered Early Childhood Educators (RECE) who have a minimum of a two-year diploma from an accredited College or University in Early Childhood Education/Studies
  - Must be registered with the College of Early Childhood Educators (CECE)
  - There must be at least one RECE in each child care program and two RECEs in a 24-child preschool program
- A clear police record check
- Certificate in Standard First-aid and CPR.
- Centre supervisors must possess all the above with the addition of two years of experience working in licensed child care settings.

- Qualifications in Early Childhood Education is <u>not</u> required, but training may be provided by child care home agencies
- A clear police record check
- · Certificate in Standard First-aid and CPR
- People residing within the child care provider's household are required to have a criminal record check.
- Qualifications in Early Childhood Education is <u>not</u> required
- May be required to provide a clear police record check
- People residing within the child care provider's household may be required to provide a police record check.

Hours of Operation

- Standard hours are typically between 7 am 6 pm, Mondays to Fridays
- Hours of operation can vary in each child care center
- Before and after school programs that are deemed to be authorized recreational and skill-building programs are permitted to operate no longer than three consecutive hours in the mornings and/or afternoons.
- Standard hours are typically between 7 am-6 pm, Mondays to Fridays, though non-standard hours may be provided
- Hours of operation can vary in each child care center.
- May provide standard and non-standard hours (overnight, early mornings, weekends, etc.)
- Up to the discretion and mutual agreement of the provider and family.

Additional Supports & Services

- Accepts <u>subsidy</u>. Only in child care centres that have been deemed eligible to accept subsidies.
- <u>Peel Inclusion Resource Services (PIRS)</u> may be available.
- Accepts <u>subsidy</u>. Only in child care homes that have been deemed eligible to accept subsidies
- <u>Peel Inclusion Resource Services (PIRS)</u> may be available.
- Does not accept subsidy
- Peel Inclusion Resource Services (PIRS) is not available.
